ELIGIBLE PURCHASES

You may be entitled to a payment if you purchased an AmeriGas or Blue Rhino Propane Tank¹ or paid to exchange an already-purchased Propane Tank for an AmeriGas or Blue Rhino Propane Tank between December 1, 2009, through November 30, 2020.

For a purchase to be eligible, you must have purchased the tank:

- **INDIRECTLY**, such as from a retail store, grocery store, or gas station, in one or more of the following Eligible States: Arizona, California, Iowa, Maine, Michigan, Minnesota, Nevada, New Mexico, North Carolina, North Dakota, South Dakota, Utah, and West Virginia; or
- **DIRECTLY** from AmeriGas or Blue Rhino through a vending machine, anywhere in the U.S.

IF YOU HAVE A PROOF OF PURCHASE: For each valid claim for which you submit a Valid Proof of Purchase, you will receive **up to \$5.00 per eligible tank**. Acceptable Proof of Purchase includes receipts, retailer loyalty card records, credit card statements, or other records that reflect your purchase or exchange of the Propane Tanks.

IF YOU DO NOT HAVE A PROOF OF PURCHASE: For each valid claim for which you **DO NOT** submit a Valid Proof of Purchase, you will receive **up to \$2.50 per eligible tank, up to a maximum of 50 tanks**.

If the total Settlement Claims submitted by all claimants exceed the funds available to pay Claims, the Claims Administrator will reduce the amounts specified above on an equal and pro rata basis so that the Settlement Claims do not exceed the funds available.

HOW YOU CAN QUALIFY FOR AND RECEIVE A PAYMENT

In order to be eligible for any compensation from the Settlement, you must: (1) fill out this Claim Form in its entirety; (2) sign the Verification Statement; and (3) return the Claim Form, along with any supporting documentation, by the **CLAIM DEADLINE: March 8, 2021**, using any of the methods below:
